

MANDURAH LEGENDS DARTS ASSOCIATION INCORPORATED BY-LAWS

1 DRESS CODE

Ladies: Black slacks, skirt or dress shorts and shirt/blouse with collar and sleeves.

Men: Black trousers or dress shorts and collared shirt with sleeves.

All:

- Proper footwear must be worn at all times open toed shoes, thongs, scuffs or sandals must not be worn. Ugg boots are not allowed.
- Black jeans are allowed if not torn or faded.

Unacceptable Attire Denim clothing, work shorts, singlet's, bike shorts, hot pants, track pants, leggings. Any shirt jacket t/shirt or top with crude or offensive designs or writing on them.

The committee can refuse any dress considered to be unsuitable.

Where medical conditions necessitate the wearing of an attire that does not conform to the above rule, then specific permission must be obtained from the committee.

No headgear shall be worn without the prior permission of the committee. Such permission will be granted on the basis of cultural, religious or medical grounds.

Players are permitted to wear sweatbands on their wrists.

State & Nationals Events: All players participating in state events need to wear an approved club event and all players participating in National events need to wear a state shirt.

2 CODE OF CONDUCT

All players are required to inform themselves and follow the Codes of Behaviour as laid out in the WA State Legends flyer "Promoting Friendship & Fellowship in Legends" which can be found at the link below.

3 REGISTRATION FEES AND NEW PLAYERS

Registration fees are proposed by the committee though any changes for a following season must be put to the members and passed at the AGM.

Fees (as of 2023 season) are \$15 for Mandurah Legends plus \$30 that is collected by Mandurah on behalf of State and National Associations. The total payment of \$45 applies to members who join Mandurah as their first association, members who are also members of another associated club will only pay the State and National fees once.

From the 3rd club day of the season all participants must be registered and financial (may pay on that day) except as noted for new players.

Fees, and other funds, can be paid in cash or through bank transfer with bank details made available on request.

New players are entitled to play one (1) club day before deciding whether to join. This only applies if the player has not previously been registered with Mandurah Legends and they will still be required to pay any match fees associated with the day.

New players are entitled to any prizes they win on that first day.

4 ELIGIBILITY FOR CLUB CHAMPIONSHIPS

To be eligible for club championship events the player must be financial and have played a minimum of two (2) games in the current season. At a members meeting in March 2024 it was agreed that the Committee can grant exemptions for FIFO work or other exceptional circumstances they deem applicable.

5 PRIZES AND AWARDS

Mystery peg will not be awarded during club championship events.

For normal club days all prizes will be awarded on the day. Winners and runners-up may be determined based on individual sheets or based on a play-off between two or more sheets. This is at the discretion of the committee with players informed at start of play.

Club championship awards will be presented at the Christmas function immediately following the AGM.

End of year awards will also be made for:

- 170 pegs
- Other pegs greater than 100
- 180's
- 171's (3 * triple 19)

6 CHALKING

Legends darts relies on our fellow players to fill the role as chalker / scorer. As a club we require all capable players to do their reasonable share of chalking when not involved in a game. However, we do recognise that in some individual circumstances there may be legitimate physical or emotional (anxiety) reasons a person may not be able to complete these duties. For normal club days this is not an issue, and our club membership is expected to be generous enough to accommodate any of these circumstances. Similarly, for club championships we expect our members to accommodate this but do require the effected individual to ensure that their teammate(s) or some of their fellow competitors, in same division, are willing to take on increased chalking responsibilities.

Regardless of above, we still encourage everyone of all abilities to have a go at chalking and stress that any members found to be abusive or disparaging to a chalker will be subject to disciplinary action as deemed appropriate by the committee.

To avoid exploitation of this by-law, the committee does reserve the right to request further reasonable information from any impacted individual which may include medical advice.
